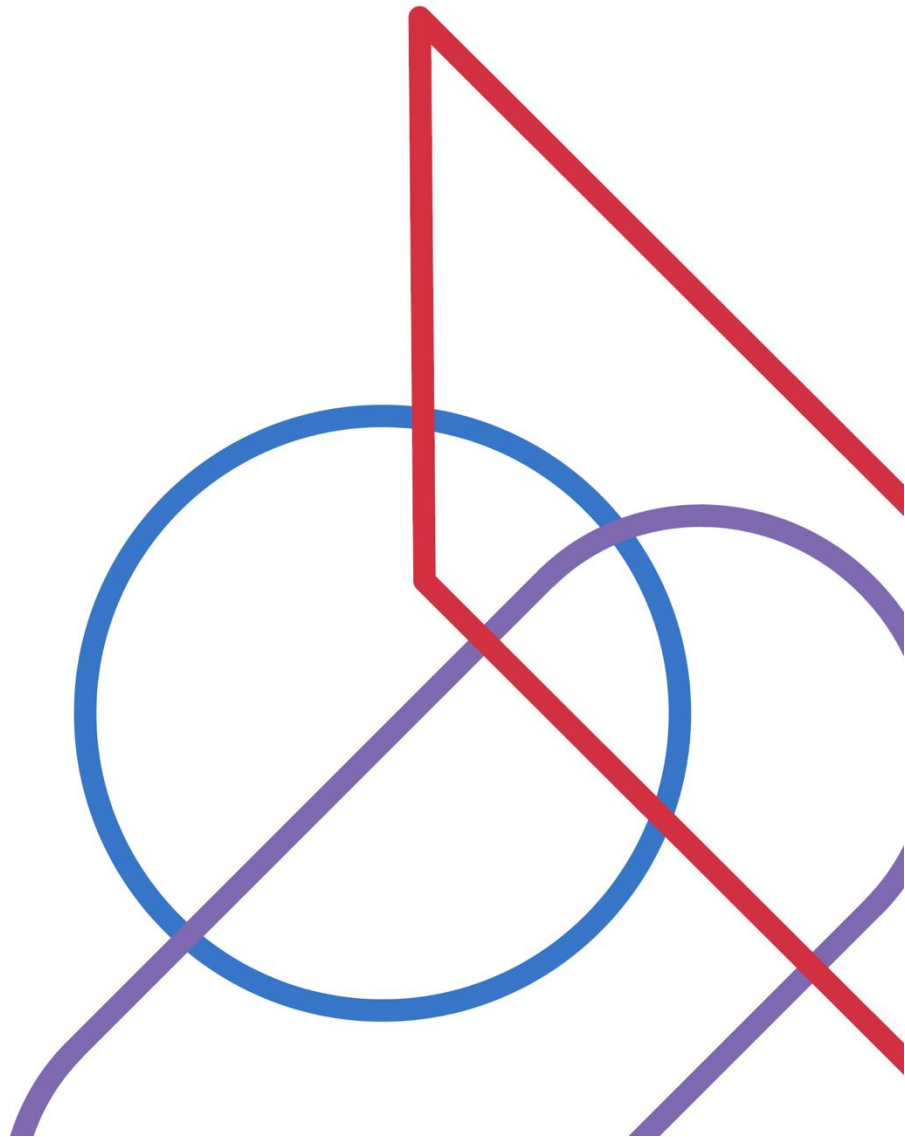

I. Executive Summary

MED-Project LLC (“MED-Project”) operates a Product Stewardship Plan for Unwanted Medicine from Households (“Plan”) in San Mateo County (the “County”) under the County of San Mateo Safe Medicine Disposal Ordinance, San Mateo County Ordinance Code Sections 4.116.010 - 4.116.190 (“Ordinance”). The San Mateo Environmental Health Services (the “Department”), approved MED-Project’s revised Plan, dated April 15, 2019, on January 16, 2020 (“Approved Plan”). This 2022 San Mateo County Annual Report (“Report”) describes MED-Project’s activities between January 1, 2022, and December 31, 2022 (“Reporting Period”). All capitalized terminology not defined in this summary is derived from the Approved Plan.

MED-Project has been in operation in the County of San Mateo since 2017 and has served the residents by collecting over 220,000 pounds of Unwanted Medicine. MED-Project’s outreach and education efforts have thus far resulted in over 43 million impressions to County of San Mateo residents, stemming from its comprehensive education and outreach program.

A. Notifications in the Reporting Period

MED-Project submitted a number of change requests and notices during the Reporting Period (notices providing status updates related to the effects of the COVID-19 pandemic are discussed in the COVID-19 Pandemic-Related Notifications section below). The change requests and notices included:

- Four quarterly Help Desk reports for reporting periods in 2021 and 2022 were submitted to the Department during the Reporting Period. The reports met requirements in the April 15, 2019, Request for Information from the Department.
- On March 24, 2022, MED-Project submitted a non-substantive change notice to the Department, notifying the Department of the withdrawal of a Vendor from the Approved Plan.
- On April 20, 2022, MED-Project notified the Department of the deactivation of a Kiosk Drop-Off Site, as listed in the notification.
- On August 29, 2022, MED-Project submitted a non-substantive change notice to the Department, notifying the Department of the addition of Vendors to Section X of the Approved Plan, as well as an update to a Vendor name.
- On December 15, 2022, MED-Project submitted a non-substantive change notice to the Department, notifying the Department of the withdrawal of a Vendor from the Approved Plan.

B. COVID-19 Pandemic-Related Notifications

On January 10, 2022, MED-Project submitted an eighth and final COVID-19 pandemic response notification, which indicated that two Kiosk Drop-Off Sites remained restricted.

By the end of the Reporting Period, these sites were no longer restricted. For details on the access status of COVID-19 pandemic-restricted sites during the Reporting Period, see Appendix O, Table 13: Reporting Period Access Restrictions.

C. Reporting Period Operations Overview

During the Reporting Period, priority was given to operating Kiosk Drop-Off Sites throughout San Mateo County, and performing public outreach to eligible pharmacies, hospitals, clinics with on-site pharmacies, and Law Enforcement Agencies (“LEAs”). During the reporting period, MED-Project’s Program collected and disposed of Unwanted Medicine from 53 Unwanted Medicine Kiosk Drop-Off Sites.

Kiosks were installed in pharmacies that meet all local, state, and federal requirements and that executed agreements with MED-Project. In addition, promotional materials, including signage and/or brochures, were distributed to select existing Kiosk Drop-Off Sites.

MED-Project provided disposal instructions to select Kiosk Drop-Off Sites and Mail-Back Services to Residents and continues to communicate with Kiosk Drop-Off Site Hosts to distribute outreach materials upon request, review procedures as needed, and improve overall Program design.

As outlined in the Approved Plan, the ultimate goal of the Program is to provide Residents with convenient, safe, and accessible methods to dispose of Unwanted Medicine.

The following Sections of the Report respond to specific reporting requirements in Ordinance Section 4.116.090. Each section of the Report restates the corresponding Ordinance requirements and provides the required information. All figures are rounded to the nearest tenth place.

II. Participating Producers

Ordinance Sec. 4.116.090(a)(1): “A list of Producers participating in the Stewardship Plan.”

III. Collection Method and Weight

A. Kiosks

MED-Project collected 45,832.2 pounds of Unwanted Medicine through Kiosk Drop-Off Sites.

B. Mail-Back Packages

MED-Project collected 93.0 pounds of Unwanted Medicine through the return of Mail-Back Packages.

- MED-Project collected 53.6 pounds through the return of 92 Standard Mail-Back Packages¹.
- MED-Project collected 6.5 pounds through the return of 8 Inhaler Mail-Back Packages.
- MED-Project collected 32.9 pounds through the return of 21 Injector Mail-Back Packages.

C. Total Weight of Collected Unwanted Medicine

MED-Project collected a total of 45,925.2 pounds of Unwanted Medicine through all collection methods.

¹ The Standard Mail-Back Package total weight provided by Vendor includes averaged weight calculation data.

IV. Kiosk Drop-Off Site Locations, Mail-Back Package Distribution, and Collection Events

B. Number of Mailers Provided to Disabled and/or Home-Bound Residents

A total of 159 Unwanted Medicine Mail-Back Packages, 39 Inhaler Mail-Back Packages, and 49 Injector Mail-Back Packages were distributed directly to Residents. Disabled and/or home-bound Residents, and persons providing services to such County Residents, were able to request Mail-Back Packages through the Call Center and/or MED-Project Website. MED-Project identifies a total number of Mail-Back Packages provided directly to residents because it is unable to verify whether the recipient is disabled and/or home-bound, or a person providing services to such County Residents.

VII. Educational Efforts and Public Outreach

Ordinance Sec. 4.116.090(a)(9): “A description of the public education, outreach and evaluation activities implemented during the reporting period.”

A. Public Education Activities

MED-Project provided disposal instructions for Kiosk Drop-Off Sites and Mail-Back Services offered through the Approved Plan. In addition, MED-Project maintained a website and toll-free telephone number to provide information pertaining to MED-Project disposal options and outreach materials. The MED-Project Website, toll-free telephone number, and outreach materials, such as posters and brochures, were available in the required languages, including English, Spanish, Chinese, and Tagalog. MED-Project Website information and statistics are provided in Appendices G and H, respectively.

B. Outreach Activities

To promote the Program during the Reporting Period, MED-Project provided digital, radio and television campaigns; provided information through the MED-Project website; posted information on social media sites; and sent email blasts. Additionally, MED-Project distributed materials, including brochures and posters, to select Kiosk Drop-Off Sites. See Appendix I for examples of promotional materials. In accordance with Section XI.D of the Approved Plan, MED-Project is including a log of when each stakeholder was provided with educational brochures during the Reporting Period. C. Evaluation Activities

As required by Ordinance Sec. 4.116.060(a)(4), MED-Project conducted a biennial survey of Residents, pharmacists, veterinarians, and health care professionals who interact with members of the community in 2022. The survey was conducted from September 12 – November 4, 2022, and the results were posted to the MED-Project Website on January 30, 2023. The survey provided MED-Project with information on the effectiveness of promotion, outreach, and public education in the County.

Twenty-nine percent of San Mateo County Residents are aware of the safe, convenient and free disposal program for expired and/or unwanted medicines for residents. Additionally, 35% of San Mateo County Residents reported using drop-off locations or mail-back methods to dispose of medicine. Of this group, 95% used Kiosk Drop-Off Site locations. Of Residents who have used the medicine disposal program, 74% believe the medicine disposal Program is easy to use, and 71% of the same group of Residents believe the program is easy to locate.

The survey also showed that 23% of providers surveyed recalled having been exposed to messaging about safe storage and disposal of unwanted and/or expired medicines. Sixty-three percent of providers encouraged their patients to use designated drop-off locations to dispose of expired or unwanted medicines in the past year. Seventy-three percent of providers who had an opinion believed the medicine disposal Program was easy to use, and 66% of providers who had an opinion felt it was easy to locate.

VIII. Packaging Recycling

Ordinance Sec. 4.116.090(a)(10): “A description of how collected packaging was recycled to the extent feasible, including the recycling facility or facilities used.”

As described in the Approved Plan, while drug packaging is expected to constitute a significant amount of the waste incinerated under the Program, MED-Project has concluded that separation of inner and/or outer packaging from Unwanted Medicine and/or recycling of packaging would raise three significant concerns:

1. Separating and recycling drug packaging could result in the disclosure of confidential patient information appearing on prescription drug packaging;
2. Separating and recycling drug packaging could increase the potential for releases and leakage of Unwanted Medicine; and
3. Separating and recycling drug packaging could increase diversion risk by adding additional steps to the collection process and because drug packaging is often used in drug counterfeiting, the drug packaging could be a diversion target itself.

For these reasons, the Program does not provide for the separation and recycling of packaging from Unwanted Medicine.

MED-Project education and outreach materials instruct Residents to return Unwanted Medicine at a Kiosk Drop-Off Site, via Mail-Back Services, or at a Take-Back Event, in its original container or a sealed bag. These materials encourage Residents who transfer their Unwanted Medicine into a sealed bag to recycle all remaining packaging.

IX. Program Goals

Ordinance Sec. 4.116.090(a)(11): “A summary of the Stewardship Plan’s goals, the degree of success in meeting those goals in the past year, and, if any goals have not been met, what effort will be made to achieve the goals in the next year.”

A. Collection Goals

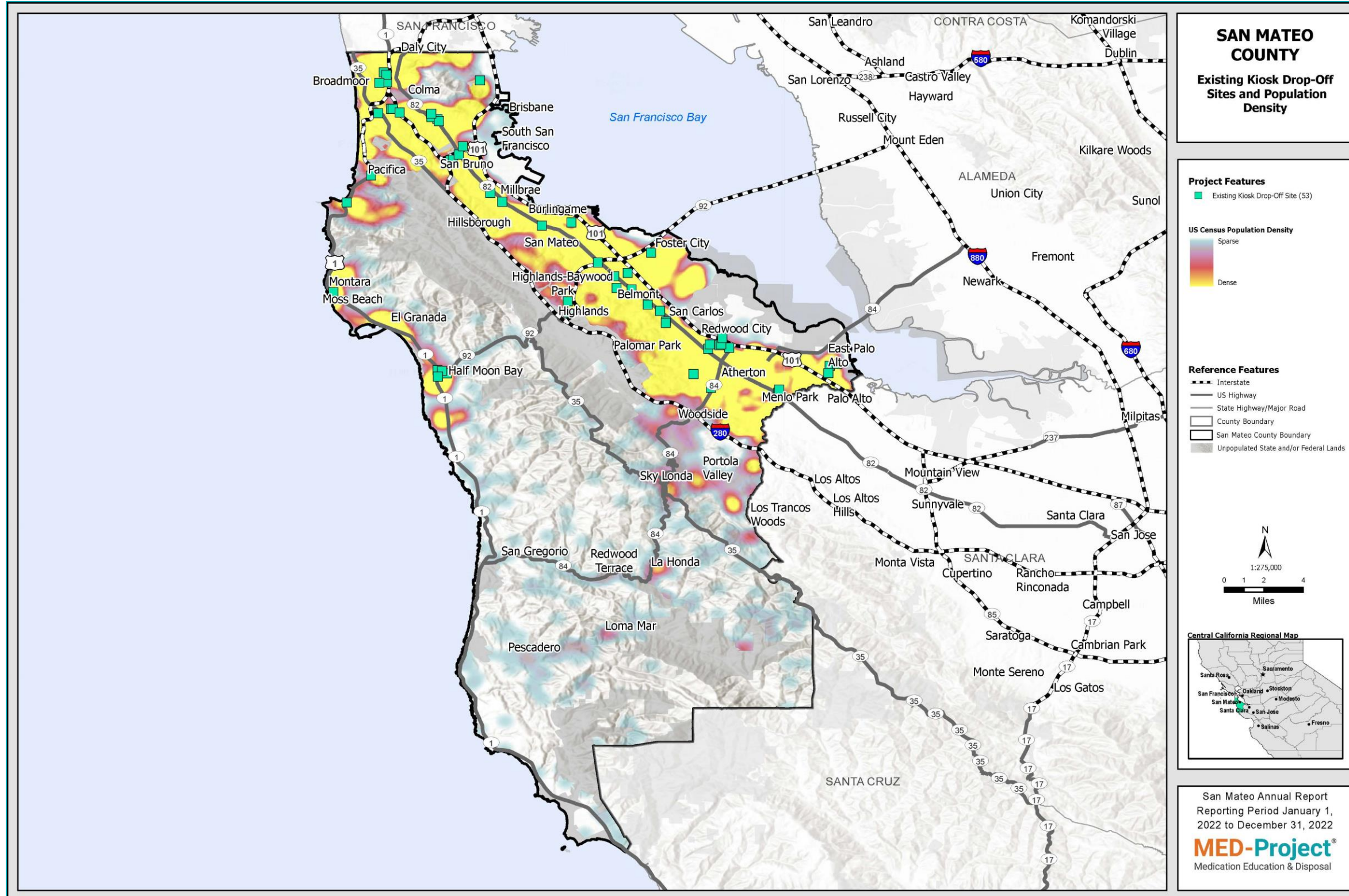


Figure 1: Map of Active Kiosk Drop-Off Sites During the Reporting Period

MED-Project met the Service Convenience Goal in Ordinance Section 4.116.050(b) during the Reporting Period through established Kiosk Drop-Off Sites Locations as provided in Appendix M; Kiosk Drop-Off Site Reporting Period Results. Figure 1 shows a graphical representation of the Service Convenience Goal during the Reporting Period with Kiosk Drop-Off Sites Locations. As discussed in the Approved Plan, Section VI, MED-Project met the long-term collection goal of establishing Kiosk Drop-Off Sites in a minimum of four out of five Supervisorial Districts and eliminated the need for using Mail-Back Distribution Locations. MED-Project operated no Mail-Back Distribution Locations during the Reporting Period.

As outlined in the Approved Plan, MED-Project set a collection expectation of 13,320 pounds for the 2018 reporting period. MED-Project exceeded the 2018 collection goal during the Reporting Period. Specific details on Unwanted Medicine collection through Kiosk Drop-Off Sites and Mail-Back Distribution Locations is available in Section III: Collection Method and Weights, of this Report. MED-Project will evaluate future collection goals as part of the next Plan update.

B. Education and Public Outreach Goals

MED-Project previously met the short-term goal of establishing baseline number of page views; LEAs, retail pharmacies, community groups, and other third parties contacted; media outlets receiving press advisories; percentage of community centers reached, and messages returned by MED-Project. Appendix N compares these values for the Reporting Period against the 2017 baseline values.

C. Collector Outreach

MED-Project continued collector outreach by issuing letters to all potential Kiosk Drop-Off Sites on February 12, 2022.

X. Program Costs

Ordinance Sec. 4.116.090(a)(12): “The total expenditures of the Stewardship Plan during the reporting period.”

The total Program cost for the Reporting Period was \$684,097.

Safety and Security Report

Event Reported Date: April 29, 2022

Location: Box and Liner originating from a County of San Mateo Kiosk Drop-Off Site

Event Summary: MED-Project was notified by its Vendor that an Unwanted Medicine box and liner that originated from a County of San Mateo Kiosk Drop-Off Site had been declared by the Carrier to be lost in transit. MED-Project understands that there have been rare exceptions in which the Carrier cannot deliver a package to its destination or return it to the shipper for reasons including, but not limited to, the loss of shipping information, such as a damaged shipping label. The Vendor has reported that the Carrier has policies and procedures for managing such packages, including destruction at a permitted medical waste incinerator.

Corrective Action Taken: MED-Project notified the County on April 29, 2022, and requested that the Vendor provide a detailed report of its investigation and findings including any information on the whereabouts of the Unwanted Medicine box and liner. In addition MED-Project requested: (1) any other outcomes from investigations into the event; (2) any reports the Vendor makes regarding this event to law enforcement or government agencies; (3) any law enforcement or government agency involvement with this event; (4) any legal proceedings involving this event, and (5) any changes in policy or procedure that the Vendor has or is planning to make as a result of the event. MED-Project also notified the Kiosk Drop-Off Site Host of the event, including information on potential reporting obligations under the Drug Enforcement Administration and California Board of Pharmacy regulations.

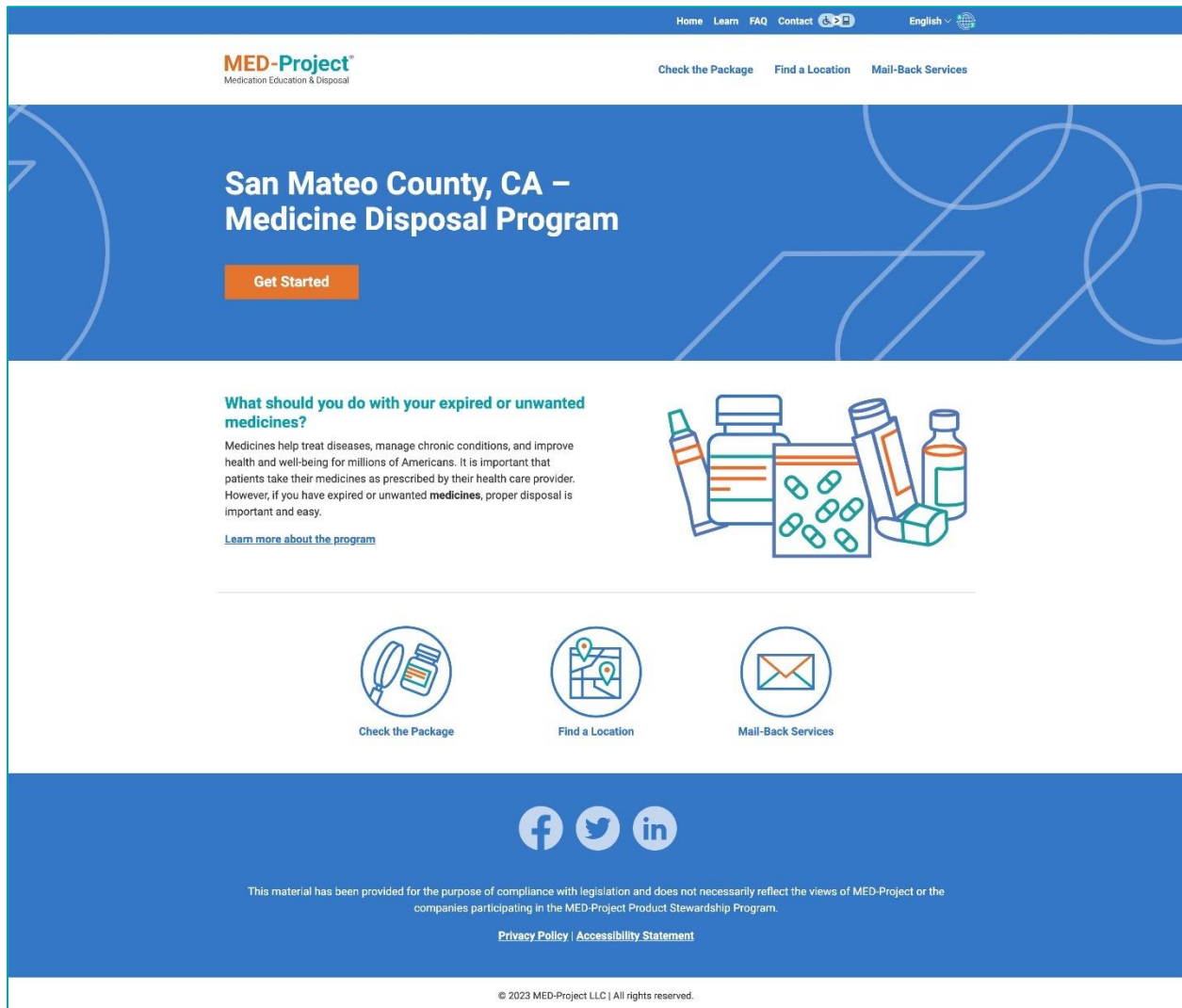



Figure 2: MED-Project Website Landing Page (December 2022)

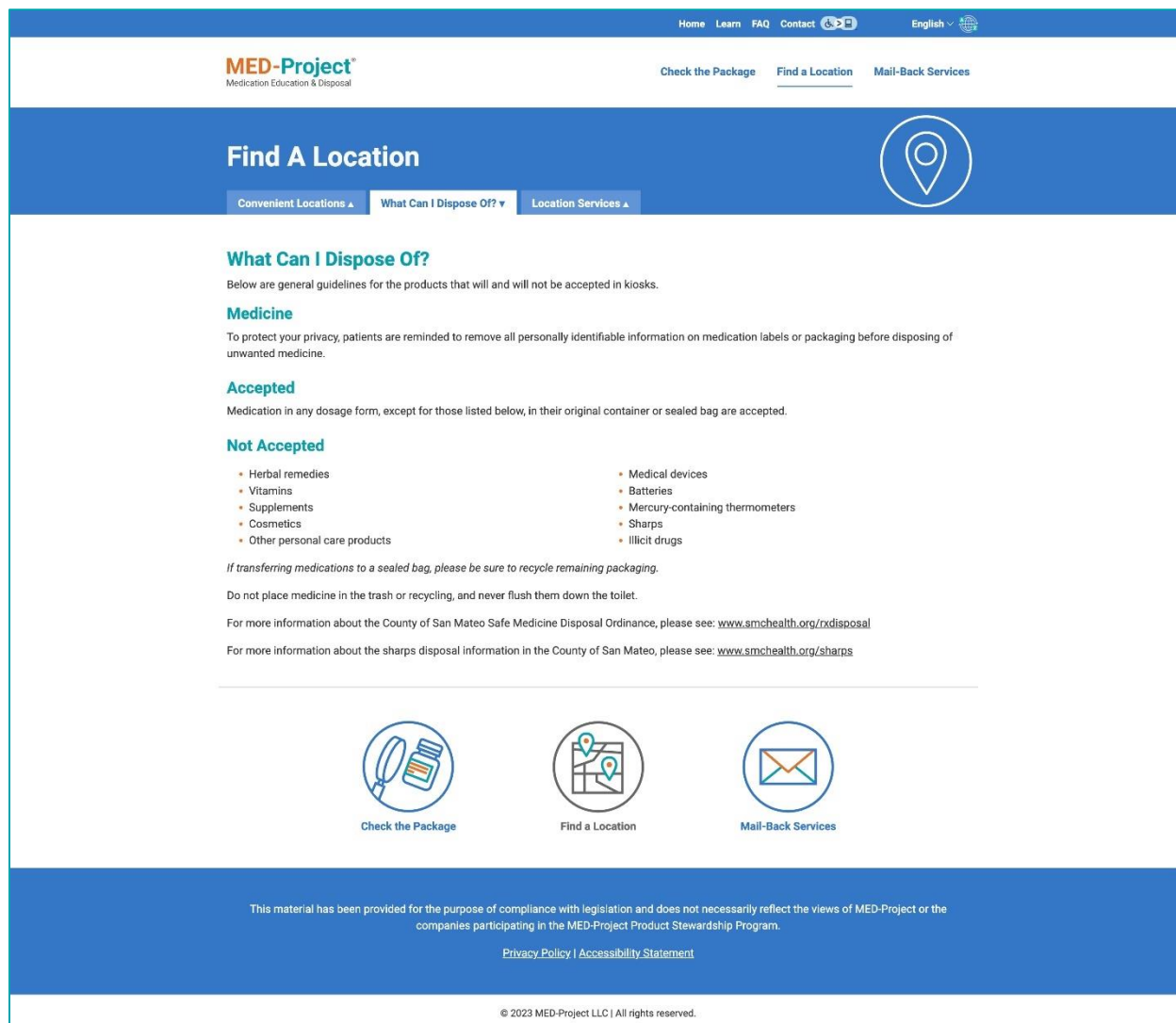


Figure 5: MED-Project Website Find A Location Page-What Can I Dispose Of Tab (December 2022)

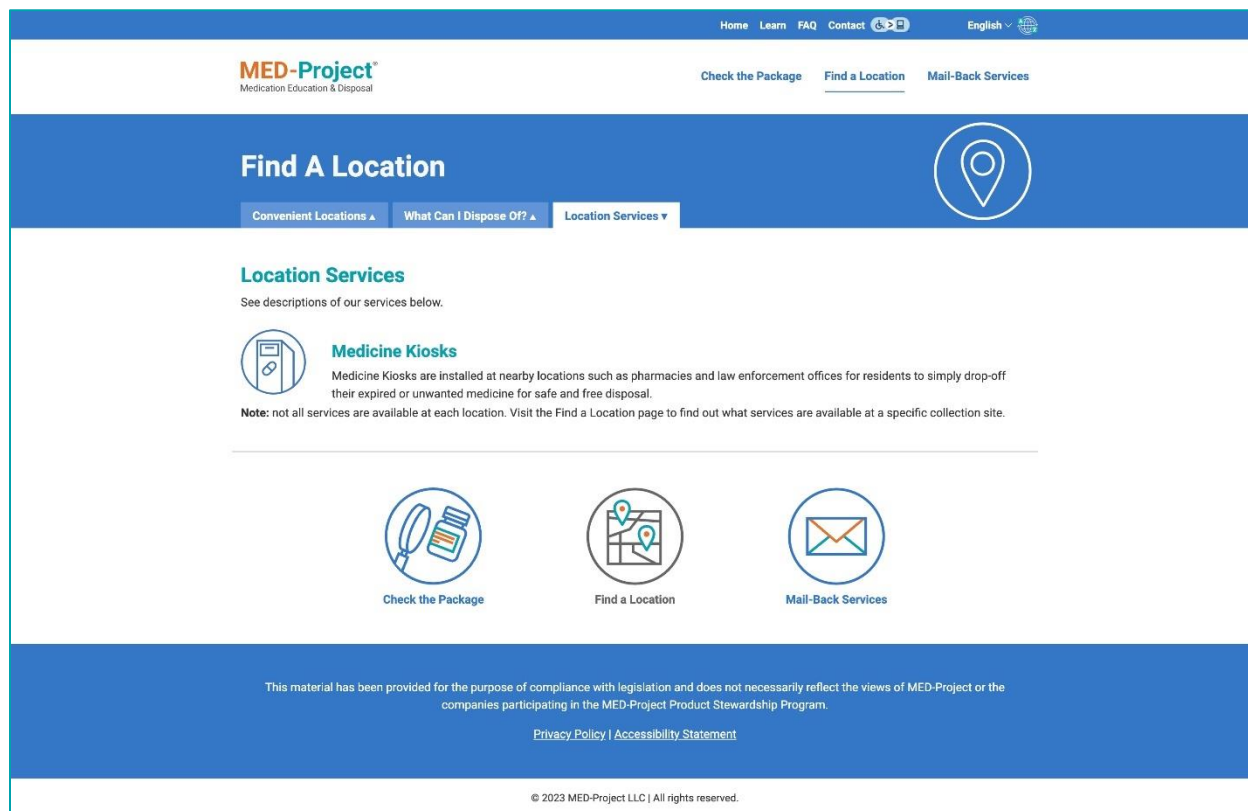


Figure 6: MED-Project Website Find A Location Page-Location Services (December 2022)




